3 - Who can enter (Eligible Entrants)	Entry is only open to Australian residents who are 18 years and over. Entry is restricted to CBH Group members only. Entry is only when a vehicle is ordered with ORIX during the months of February, March and April 2020.

General

Information on how to enter, dates and prizes as set out in the Schedule form part of the Terms and Conditions of Entry (**Terms and Conditions**) for each competition conducted under the Blanket Permit (each a **Competition**). Entry into this Competition deems acceptance of these Terms and Conditions.
3. To the extent of any inconsistency between these Terms and Conditions and any other reference to this Competition, these Terms and Conditions prevail.

Who can enter

4. Subject to any age restriction specified in item 3 of the Schedule, entry is open to all residents of Australia who fulfil the requirements set out in the Schedule.

How to enter

6. Entries must include all requested contact details, including a valid email or postal address (as requested), to be eligible to win. Entrants may only enter in their own name. Inaudible, incomprehensible, illegible, and incomplete entries will be deemed invalid.

Number of Entries permitted

7. Eligible Entrants may enter this Competition as often as is specified in Item 5 of the Schedule.

Open, Close, Draw and Publish dates

8. The Competitions conducted under this Blanket Permit commence on 19/08/2019 at 12:01 AM AEST/ AEDT and closes on 18/08/2020 at 11:59 PM AEST/ AEDT. (**Blanket Promotional Period**). Entries for each Promotion must be received by the Promoter prior to the Competition close date and time. The final draw will occur no later than 19/08/2020 at 11:00 AM AEST/ AEDT.
9. Each individual Competition conducted under the Blanket Permit will open, close and be drawn on the date specified in Item 2 of the Schedule. All draws will be conducted at the premises of ORIX Australia, 1 Eden Park Drive, Macquarie Park, NSW 2113.
10. The Promoter will ensure that all entries have an equal chance of winning the major prize.
