

## Spring Promotion - Promotional Terms (September 2024)

These Promotional Terms apply in addition to the [Vehicle Rental – Terms LEG-AU-VR-SC-06/24 \(Rental Terms\)](#) that apply to a customer's Agreement (as defined in the [Rental Terms](#)). In the event of any inconsistency between the Promotional Terms and the Rental Terms, these Promotional Terms will prevail to the extent of the inconsistency.

- 1. Promotional Period** – 6 September 2024 to 25 October 2024
- 2. Eligible Bookings** – Any customers who make a new rental booking with ORIX during the Promotional Period for a Promotional Vehicle with a rental term of at least four (4) consecutive weeks with an expected and actual commencement date during the Promotional Period.
- 3. Promotional Pricing** –
  - 3.1 Promotional Pricing - For Eligible Bookings, provided the below conditions have been satisfied, Customers will receive a credit from ORIX for the base rental payment covering the fifth week. The Customer will still need to pay for any other amounts that are due in accordance with the terms of their Rental Agreement on top of the base rental payment for that fifth week, including, but not limited to, the Daily Loss Liability Reduction Fee (if selected) and the charges for any additional services (e.g. telematics services) and consumables (including fuel, Adblue and oil etc).
  - 3.2 The Customer and the Eligible Booking will need to satisfy the following conditions before the Customer can receive the Promotional Pricing:
    - a) The Eligible Booking was made in advance of the requested rental term;
    - b) A Promotional Vehicle is available for the period that the Customer wishes to book for;
    - c) The Customer is up to date with their payments (including having paid for the first four weeks' rental charges and payments to be eligible for the Promotional Pricing and is not in breach or default of their Rental Agreement (for this rental booking and for other rental bookings the Customer has with ORIX); and
    - d) On the ORIX Rental Officer's reasonable determination, the rental booking is not replacing an existing rental booking that would otherwise have continued if the Promotion was not running.
  - 3.3 The Promotional Pricing is only available once for each Eligible Booking. This means, if a Customer has made an Eligible Booking for 10 weeks, the Customer will only receive the one week's base rental payments free in the fifth week (in the form of a credit for the base rental payments for that fifth week). In the event the Customer extends their booking, they will not be eligible for another free week.
  - 3.4 Customers can make multiple Eligible Bookings and receive the Promotional Pricing on each Eligible Booking.
  - 3.5 The free week cannot be transferred, exchanged or redeemed for cash.
  - 3.6 The Promotional Pricing cannot apply to an existing booking made before the Promotional Period.
  - 3.7 In the event that it is discovered that a Customer Event of Default, as defined in the Rental Agreement was in existence prior to the Customer receiving Promotional Pricing which ORIX had not been aware of at the time and would have meant that the Customer was not complying with clause 3.4(c) of these Promotional Terms (and thereby not entitled to receive Promotional Pricing), the Customer agrees that ORIX may issue the Customer with an invoice for the rental charge for the free period and the customer will pay this invoice within thirty days of receipt.

**Example** – Customer A has an Eligible Booking and is paying \$400 per week as the base rental charge (with an extra \$50 a week for requested telematics services and \$5 per day as the requested Daily Loss Liability Reduction Fee). In the fifth week, Customer A will only need to pay \$50 for the requested telematics services and \$5 per day as the Daily Loss Liability Reduction Fee (i.e. if the Customer paid \$400 for base rental charge for the fifth week, the Customer will receive a credit of \$400 back).

#### 4. Promotional Vehicle –

A Promotional Vehicle is a vehicle described in the table below.

The Promotional Vehicles are subject to availability. Should a Promotional Vehicle not be available at the time of booking for your requested booking period, ORIX may not be able to offer the Promotional Pricing to you. ORIX will not be able to offer you a raincheck for the Promotional Pricing. ORIX reserves the right to update this list of vehicles as availability changes from time to time.
